hereinafter called the grantee:

**Witnesseth:** That the grantor, for and in consideration of the sum of \$10.00 and other valuable considerations, receipt whereof is hereby acknowledged, by these presents does grant, bargain, sell and convey unto the grantee, including the heirs, legal representatives and assigns of individuals and the successors and assigns of corporations as the case may be, all that certain land situate in Bay County, Florida, viz:

UNIT 15

Commence at the intersection of the South Right-of-Way line of 19th Street and the East Right-of-Way line of Molitor Avenue; thence South along the East Right-of-Way line of Molitor Avenue 75.33 feet to the Point of Beginning; thence East at an angle of 90 degrees 07 minutes 35 seconds to the left along the extended centerline of a common wall for 141.97 feet to the West side of a 16 foot Road; thence South at an angle of 90 degrees 07 minutes 35 seconds to the right along said Road 24.25 feet; thence at angle of 89 degrees 52 minutes 25 seconds to the right for 143.97 feet to the East Right-of-Way line of Molitor Avenue; thence North at an angle of 90 degrees 07 minutes 35 seconds to the right along said Right-of-Way line 24.25 feet to the Point of Beginning, being a part of Lots 2 and 17, Block 7 St. Andrews Bay Real Estate Company's Plat Recorded in Plat Book 4, Page 57 in the Public Records of Bay County, Florida.

To Have and to Hold, the same in fee simple forever.

And the grantor hereby covenants with said grantee that it is lawfully seized of said land in fee simple; that it has good right and lawful authority to sell and convey said land; that it hereby fully warrants the title to said land and will defend the same against the lawful claims of all persons whomsoever; and that said land is free of all encumbrances except taxes and assessments for the year 19 87; Subject to Declaration of Covenants, Restrictions, and Party Wall of Continental Oaks recorded in Official Records Book 1062, page 1529; to the extent the same are valid or enforceable.
