APPOINTMENT OF CERTAIN OFFICERS FOR PURPOSES OF EXECUTING CERTAIN DOCUMENTS

WHEREAS, the Company desires to execute documents necessary to effectuate the following enumerated transactions in respect to any of the mortgages or deeds of trust (the "Mortgages" and the "Deeds of Trust" respectively) and promissory notes secured thereby (the "Mortgage Notes") for which the Company is the Servicer and for which Provident Funding Associates, L.P. - The full satisfaction/release of a Mortgage or Deed of Trust or full reconveyances upon payment and discharge of all sums secured thereby including without limitation cancellation of the related Mortgage Note.
